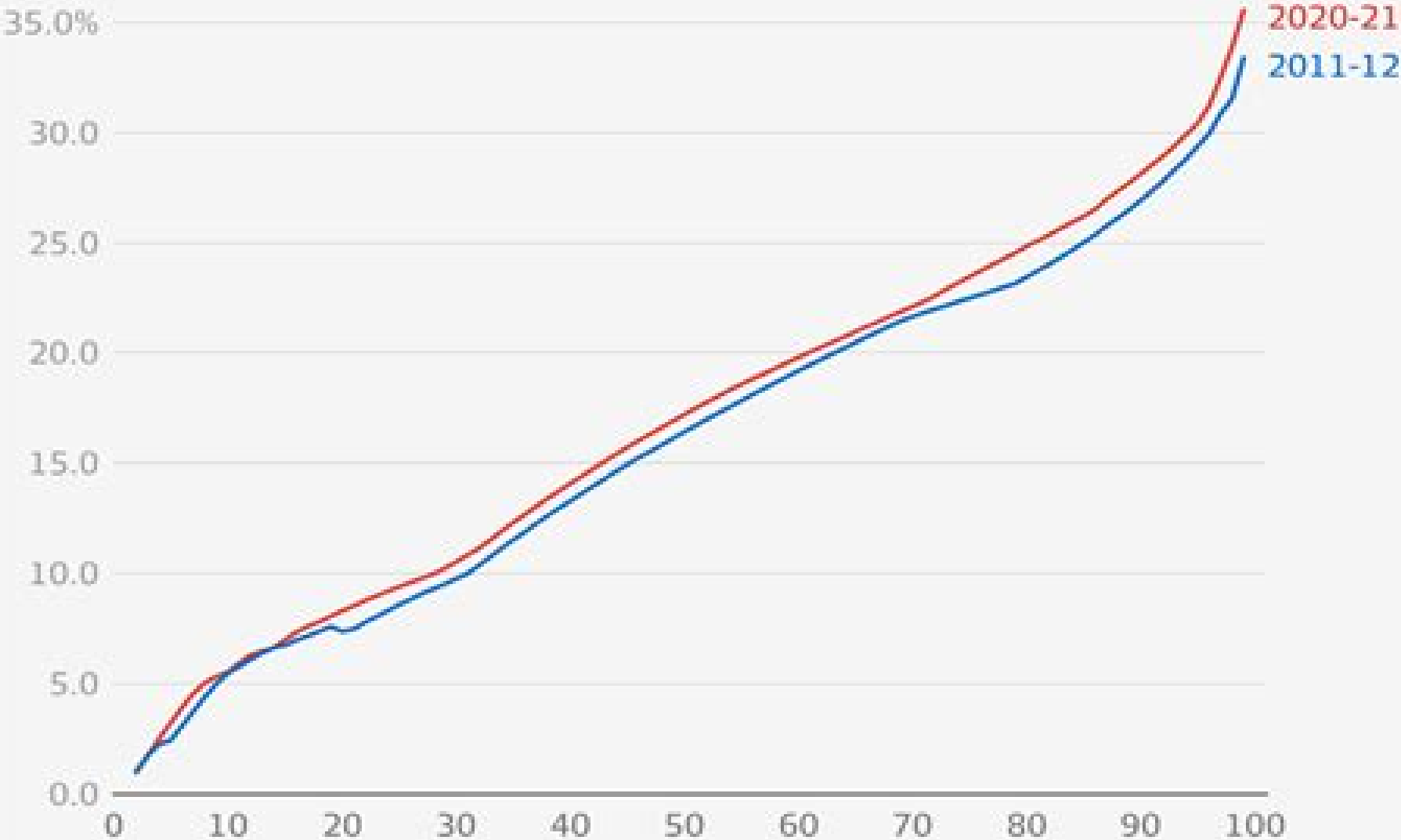


# Effective tax rate by taxable income percentile
