This new edition addresses issues around planning permission, statutory authority and other consents. The agent of change principle and deeds of easement applicable to new housing developments are analysed. This edition also covers extensively housing licensing, anti social behaviour provisions and recent legislation on public nuisance and anti social behaviour.
