Build a broad understanding of work previously conducted, identify gaps in understanding of the topic, and position your own research to build on prior knowledge.

Formulate a Hypothesis

What are the general causes of the phenomenon you're wondering about?

Select a Research Method and Design a Study

Select a research method appropriate to answer your question. Typically, your research question influences the method you will use.

Collect Data

Collect information on the topic using the research design.

Based on findings, what new questions do you have? How can these new questions help develop future projects?

Analyze Data

Organize and analyze the data after it is collected. If the analysis does or does not support the hypothesis, discuss implications for theory or policy.

Report Findings

Share results at conferences and in academic journals. Before the conclusions of a study are widely accepted, the studies are often repeated. New research questions may emerge to inspire more research projects.
