Legal, ethical and professional issues in mental health nursing

Main points

- In addition to the legal and ethical issues of the broader nursing profession, there are specific issues relevant to mental health nursing.
- Each state and territory of Australia has a *Mental Health Act*, which sets out the legal requirements and framework for mental health service provision.
- The potential for treatment being given against the will of the person concerned creates significant ethical issues for nurses.
- The practice of mental health nursing is expected to conform to professional standards.

Definitions

Ethics: The philosophical consideration of what makes specific actions morally correct.

Legislation: An Act of parliament that provides legal regulation for specific activities or behaviours. It may specify what can be done, what cannot be done or a combination of both.

INTRODUCTION

There are similarities between mental health nursing and other specialties with respect to legal, ethical and professional issues. For example, from a legal perspective, the mental health nurse is subject to the same regulation as a nurse employed in an intensive care unit in relation to practices such as the administration of medication.
