



STEPS TO PROTECTING WORKERS FROM FORKLIFT HAZARDS

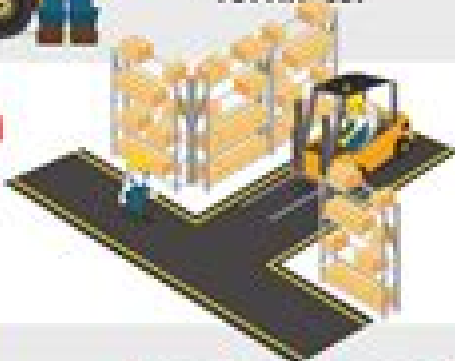


Only **trained and licensed** personnel can operate forklifts.



Keep loads **secure** to prevent falls. Make sure the area is clear, so no personnel are harmed.

Cautiously approach ramps, turns, and aisles while driving the forklift.



On ramps, **tilt load back** pointing up hill and **drive reverse** while descending.



Immediately report damages or issues to your supervisor while on the job.



If forklift is being used to elevate a worker, make sure worker **uses restraints** and is elevated using a **platform or cage**.

Do not overload past forklift's capacity. Keep load balanced and slightly raised so it clears the ground while transporting.



Use seat belts, assigned seats and no joy riding while operating. When work is complete, **engage brakes, lower forks and turn off controls.**
