

# KEY TERMS

## NON-SMALL CELL LUNG CANCER (NSCLC)

Lung cancer is the most common cancer worldwide and NSCLC accounts for about 80%-85% of all lung cancer cases.<sup>1,2</sup> The three main types of NSCLC are adenocarcinoma, squamous cell carcinoma, and large cell carcinoma.<sup>3</sup>

## BIOMARKER

A biological characteristic that can be measured in tissue, blood, or other bodily fluids. In oncology, biomarkers might be specific genetic abnormalities that may be identified as the "driver" that is causing the cancer to grow and spread. Other terms to describe biomarkers are: "molecular marker" or "genotype."<sup>2</sup>

## COMPREHENSIVE BIOMARKER TESTING

Testing that is conducted to identify and understand the unique characteristics of a person's cancer, ideally before treatment begins. In the case of lung cancer, the biomarkers, or biological markers, tested will depend on the stage of NSCLC at diagnosis. Some common biomarkers are alterations in ALK, BRAF, EGFR, HER2, KRAS, MET exon 14 skipping, NTRK, RET, and ROS1, or proteins such as PD-L1. One mechanism of biomarker testing is next generation sequencing (NGS), mutation, genomic, or molecular testing.<sup>4</sup>

## TISSUE BIOPSY

A tissue biopsy is a procedure performed with a special biopsy needle or during surgery to remove tissue or cells from the body for examination under a microscope to determine if lung disease or cancer is present. The tissue collected can also be used for biomarker analysis.<sup>4,5</sup>

## LIQUID BIOPSY

Another type of comprehensive biomarker testing that is considered non-invasive. This is a type of blood test that can identify the tumor's DNA to determine the presence of certain biomarkers. Liquid biopsies can also be used to monitor a patient's response to therapy.<sup>6</sup>

## TARGETED THERAPY

In cancer, a medicine that specifically targets a certain molecular subtype of a tumor, rather than chemotherapies or immunotherapies that treat the cancer more broadly. Targeted therapies may also be referred to as "precision medicine" or "personalized medicine."<sup>7</sup>

## MET

MET stands for mesenchymal-epithelial transition. It is a type of protein that is key to biologic processes such as organ development, tissue repair and wound healing.<sup>8</sup>
