Limits:

- If the limit of a function as x approaches a constant (c) exists then the function is interrupted.
- Types of Discontinuities:
 - Hole (removable)
 - Jump Discontinuity (non-removable)
 - Infinite Discontinuity (non-removable)
- If limit from the right isn't the same as the limit from the left then the limit does not exist (DNE).
- Limit of a constant is the constant itself.
- Plug in the value for x (c) to solve for basic limits (duh).
- To solve limit questions where you get the indeterminate form of $0/0$ or ∞/∞ you can:
 - SUBSTITUTE (ALWAYS CONSIDER THIS FIRST! But since you got the indeterminate form move on to the next steps)
 - Factor
 - Rationalize
 - Simplify/Use Identities
 - Common denominator (usually for numerator when there are fractions).
