Assuming that action brought Indians against counties seeking rental value of certain lands ceded State in 1795, on ground that the Indians' right to possession of such lands had been confirmed by treaties with United States and that the cession without the consent of the United States was required by the Nonintercourse Act, was essentially a possessory action, based on allegation required of such a well-pleaded complaint, i.e., the right to possession, asserted a current right to possession conferred by federal law, wholly independent of state law, and not asserted solely in anticipation of a federal question jurisdiction. That assertion of a federal right to possession, was wholly implausible, foreclosed by prior decisions of the Court, or otherwise devoid of merit; that, accordingly, the complaint asserted a controversy arising under the Constitution, treaties of the United States, or federal statutes; that the "well-pleaded complaint" rule is not changed; and that upholding federal jurisdiction was not inconsistent with statute granting, with certain exceptions, civil jurisdiction over Indians to the state. Reversed and remanded.
