- idea that general legal principles are embodied in judicial opinions, that by legal analysis the correct principle can be discovered and that judges can apply those principles dispassionately, free of political bias and personal prejudice
- -in other words, the notion that there is **distinct legal reasoning**, based in **legal precedent**, that is **uniquely suited to arrive at just outcomes**
