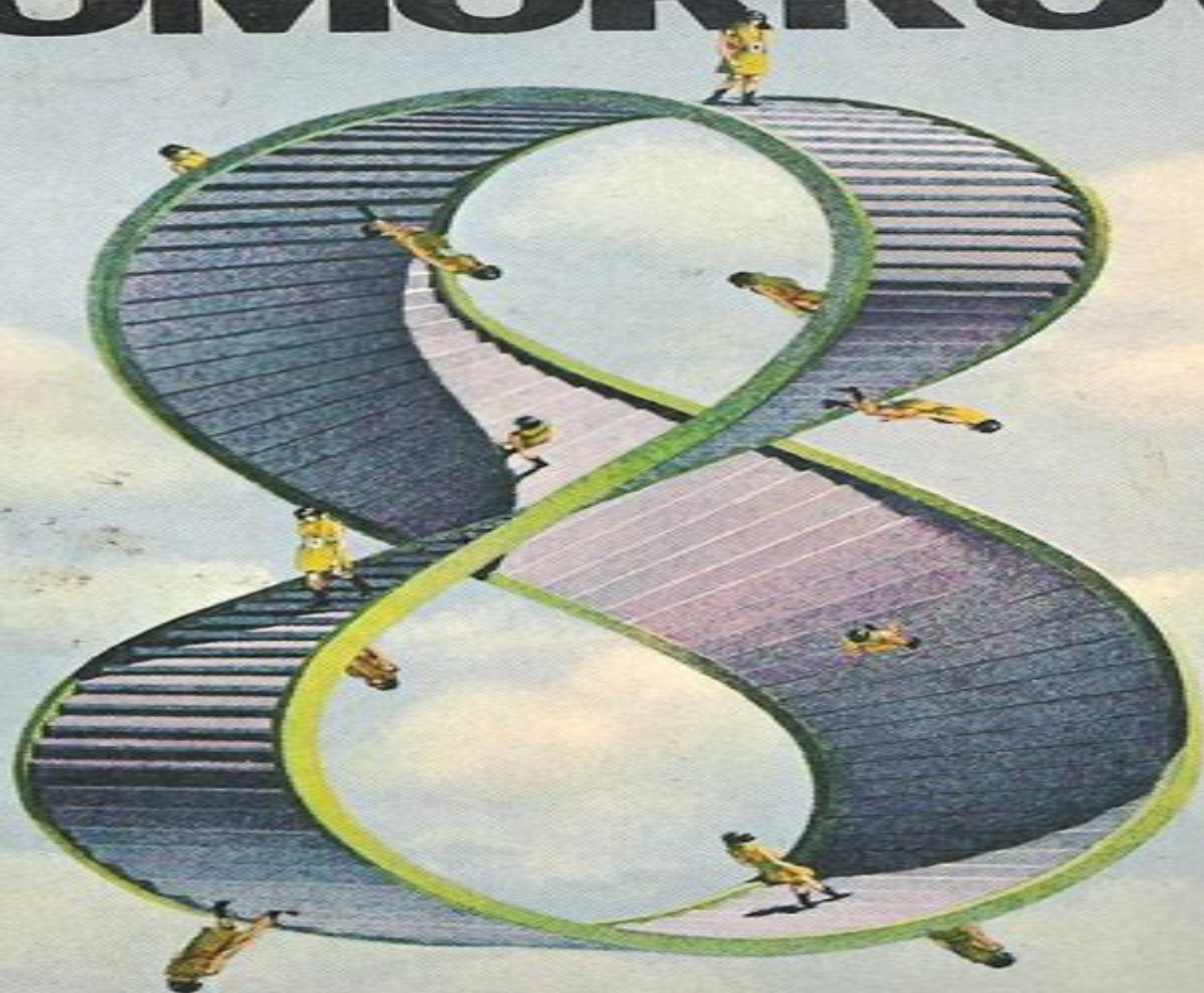

way they can go to the next stage A stage that will see them realise economies of scale and be able to offer the highest quality products at lower prices different from what the FTC and its allies are regarding as benefits What can be beneficial to the consumers if the products are okay cheaper But of poor quality as compared to what can be achieved What do you call competition and variety when you refer to small sized early entry companies most of whom only make a profit to remain in business without any to invest That makes us ask What are the real motives of these agencies Are they milking these tech giants or planning to Who are the real people or agencies harming the people Are all these agencies clean or they are the worst competition blockers Masters of poor service provisions and involved in human hacking for stealing data secretly and using this to get illegal donations as they pass tips We know tech giants breach privacy and personal data laws too Tom Horn in Life and Legend Larry D.
