

## GENERAL RULES OF LEGAL WRITING

### INTRODUCTION:

#### What is legal writing?

Legal writing = communicating information or advice, usually in a letter to a client or to another professional, or in a report or a memorandum presenting the results of legal research.

During this module, the focus is going to be on your **legal writing skills**, rather than your knowledge of the law.

#### Legal writing is a skill which includes: "Non-exhaustive list"

1. The writing of a letter to your client or other parties in relation to a litigation matter.
2. The writing of a letter on behalf of your client to a company or private individual.
3. The writing of an attendance note (potentially attendance note of a conference call, meeting).
4. Drafting a research memo after having carried out research in relation to an area of law.
5. The writing of an email to another professional

The letter you write while working on a matter is a permanent record

### WRITE FOR YOUR AUDIENCE:

It is essential to keep in mind who the **reader** of your document will likely be. – you should change your style accordingly.

**When thinking about your audience, consider whether you are writing to a professional or lay person.**

#### 1. If you are writing to legal professionals:

- It will be appropriate to include citations of case law and statutory references.
- You are also free to adopt a more formal tone, including the law you are relying on without explaining what the law means.

#### Example:

The goods in question are not fit for purpose and have been returned to you by our client within the contractual period according to your return policy. If our client will not have received a refund within 10 working days in accordance with the terms of the contract, we reserve our right to issue proceedings against your client.

#### 2. If you are writing to lay persons:

- Avoid use too citations and statutory references and
