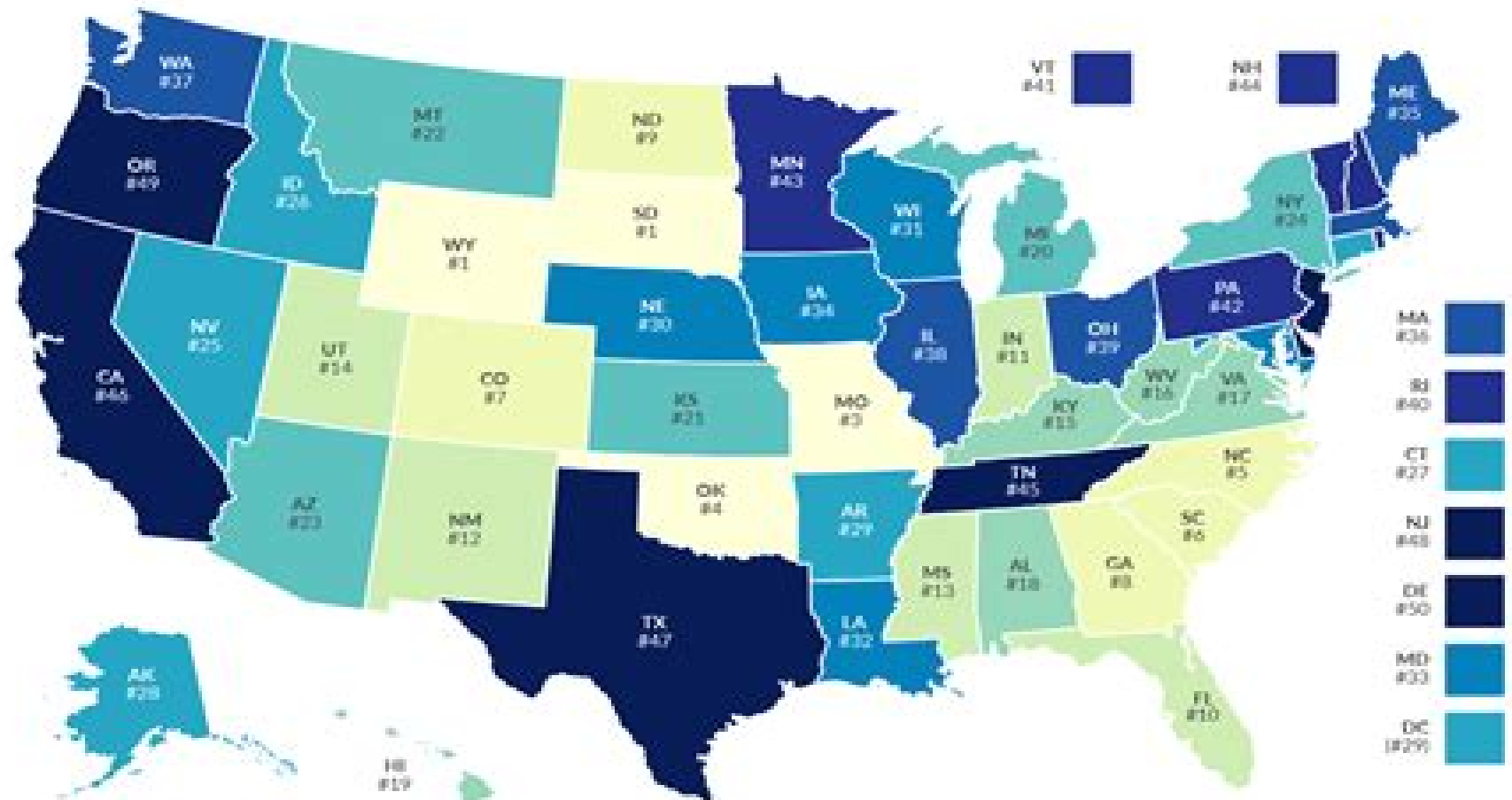


# How Does Your State Rank on Corporate Taxes?
