

HOW TO READ A SAFETY DATA SHEET

OSHA Brief

The Hazard Communication Standard (HCS) (29 CFR 1910.1201), revised in 2012, requires that the chemical manufacturer, distributor, or importer provide Safety Data Sheets (SDSs) (formerly MSDSs or Material Safety Data Sheets) for each hazardous chemical to downstream users to communicate information on these hazards. This brief provides guidance to help workers understand a standard chemical to become familiar with that label and understand the contents of the SDSs.

The SDS includes information such as the properties of each chemical, its physical, health, and environmental health hazards, protective measures, and safety precautions for handling, storage, and transport of the chemical. This information contained in the SDS must be in English (although it may be in other languages as well). In addition, OSHA requires that SDSs prominently provide specific information as detailed in appendix D of 29 CFR 1910.1201. The SDS program may also include information in other languages.

Hazard Communication Standard Safety Data Sheet Sections 1 through 8 contain general information about the chemical, identification, hazards, classification, safe handling practices, and emergency-control measures. This information should be helpful to those that need to get the information quickly. Sections 9 through 12 are to contain either technical and scientific information and chemical properties, toxicology and reactivity information, toxicological information, exposure control information, and other information including the state of preparation or last revision. The SDS must also state that the applicable information was used when the product was last released information for any required element.

The SDS must also contain Sections 13 through 15, to be consistent with the 15th Globally Harmonized System of Classification and Labeling of Chemicals (GHS), but OSHA will not enforce the content of these sections because they contain matters handled by other agencies.

Section 1: Identification

THIS SECTION IDENTIFIES THE CHEMICAL, OR THE SDS, AS WELL AS THE RECOMMENDED USES. IT ALSO PROVIDES THE ESSENTIAL CONTACT INFORMATION OF THE SUPPLIER.

- Product identifier used on the label and any other common names or synonyms by which the substance is known.
- Supplier's name, address, telephone number, fax number, e-mail address, and other appropriate party, and emergency phone number.
- Recommended use of the chemical (e.g., a brief description of what it actually does, such as flame retardant), and any restrictions on use (including recommendations given by the supplier).



Section 2: Hazard(s) Identification

THIS SECTION IDENTIFIES THE HAZARDS OF THE CHEMICAL PRESENTED ON THE SDS AND THE APPROPRIATE WARNING INFORMATION ASSOCIATED WITH THOSE HAZARDS.

- The hazard classification of the chemical (e.g., flammable liquid, category 2).
- Signal words.
- Hazard statements.
- Precautionary statements (e.g., diagrams or hazard symbols may be represented as graphical symbols (e.g., hazard pictograms) and/or text or a description of the nature of the hazard (e.g., hazard statements).

Section 3: Ingredient Information

THIS SECTION IDENTIFIES THE INGREDIENTS CONTAINED IN THE PRODUCT, INDICATES ON THE SDS, INCLUDING IMPORTERS AND MANUFACTURERS, AND INCLUDES INFORMATION ON HAZARD, TOXICITY, AND OTHER INFORMATION AS REQUIRED BY OSHA.

- Substances**
 - Chemical name.
 - Common name and synonyms.
 - Chemical abstracts number (CAS number) and other unique identifiers.
 - Impurities and stabilizing additions.
 - Any other information that may be relevant to the hazard classification of the chemical.
- Quantities**
 - Some information required for substances.
 - The chemical name and concentration (weight percentage) of all ingredients which are classified as health hazards and are present above their toxic concentration limits.
 - Provide a health hazard (the cut-off concentration limits).
- Other information**
 - The concentration (weight percentage) of each ingredient must be specified except concentration ranges may be used in the following cases:
 - A trade secret claim is made.
 - There is a health hazard statement.
 - The SDS is used for a group of substantially similar mixtures.
 - A statement that the specific chemical identity and/or concentration has been withheld as a trade secret is required.
 - A chemical, as defined in the HCS, is any substance, mixture of substances, or preparation.



Section 4: First-Aid Measures

THIS SECTION PROVIDES THE INITIAL CARE THAT SHOULD BE GIVEN BY UNTRAINED RESPONDERS TO AN INDIVIDUAL WHO HAS BEEN EXPOSED TO THE CHEMICAL.

- Emergency first aid instructions by relevant routes of exposure (inhalation, skin and eye contact, and ingestion).
- Description of the most important symptoms or effects, and any symptoms that are acute or chronic.
- Recommendations for immediate medical care and special treatment needed, when necessary.

Section 5: Fire-Fighting Measures

THIS SECTION PROVIDES RECOMMENDATIONS FOR FIGHTING A FIRE CAUSED BY THE CHEMICAL.

- Recommendations of available extinguishing equipment, and information about extinguishing equipment that must not be used.
- Advice on specific hazards that develop from the chemical during the fire, such as any hazardous combustion products created when the chemical burns.
- Recommendations on special protective equipment or precautions for firefighters.

Section 6: Accidental Release Measures

THIS SECTION PROVIDES RECOMMENDATIONS ON THE APPROPRIATE RESPONSE TO SPILLS, LEAKS, OR RELEASES, INCLUDING CONTAINMENT AND CLEANUP PROCEDURES TO PREVENT OR MINIMIZE EXPOSURE TO PEOPLE, ANIMALS, OR THE ENVIRONMENT. IT MAY ALSO INCLUDE RECOMMENDATIONS ON SPECIAL PROTECTIVE EQUIPMENT FOR LAW ENFORCEMENT OFFICIALS WHERE THE SPILL COULD HAVE A SIGNIFICANT IMPACT ON THE PUBLIC.

- Use of personal protective equipment (such as removal of ignition sources or providing sufficient ventilation) and protective equipment to prevent the contamination of skin, eyes, and clothing.
- Emergency procedures, including instructions for containment, cleanup, and disposal, when needed, and appropriate protective clothing.
- Methods and materials used for containment (e.g., covering the spill and covering surrounding areas).
- Chemical procedures (e.g., separation techniques for mixtures, decontamination, cleaning or separating, absorption materials, and/or equipment required for containment/clean up).

Section 7: Handling and Storage

THIS SECTION PROVIDES GUIDANCE ON THE SAFE HANDLING PRACTICES AND CONDITIONS FOR SAFE STORAGE OF CHEMICALS.

- Precautions for safe handling, including recommendations for handling hazardous chemicals, minimizing the release of the chemical into the environment, and providing advice on general practices or activities (e.g., mixing, blending, and other uses in production).
- Recommendations on the conditions for safe storage, including any incompatibilities.
- Provide advice on specific storage requirements (e.g., ventilation requirements).

Section 8: Exposure Controls/Personal Protection

THIS SECTION INDICATES THE EXPOSURE LIMITS, ENGINEERING CONTROLS, AND PERSONAL PROTECTIVE MEASURES THAT CAN BE USED TO MINIMIZE WORKER EXPOSURE.

- OSHA Permissible Exposure Limits (PELs), American Conference of Governmental Industrial Hygienists (ACGIH) Threshold Limit Values (TLVs), and any other exposure limit value recommended by the chemical manufacturers, importer, or employer preparing the safety data sheet, where available.
- Appropriate engineering controls (e.g., use local exhaust ventilation, or enclosure with exhaust system).
- Recommendations for personal protective measures to prevent illness or injury from exposure to chemicals, such as personal protective equipment (PPE) (e.g., appropriate types of eye, face, skin, or respiratory protection needed based on hazards and potential exposures).
- Any special requirements for PPE, including cleaning or maintenance (e.g., type of glove material, such as nitrile, for nitrile gloves, and temperature range of the glove material).



Section 9: Physical and Chemical Properties

THIS SECTION IDENTIFIES PHYSICAL AND CHEMICAL PROPERTIES ASSOCIATED WITH THE SUBSTANCE OR MIXTURE.

- Appearance (physical state, color, odor).
- Odor threshold.
- pH.
- Boiling point/boiling range.
- Initial boiling point and boiling range.
- Flash point.
- Flammable range.
- Auto-ignition temperature.
- Decomposition temperature and pressure.
- Stability.
- Aggregates (physical state, color, odor).
- Odor threshold.
- pH.
- Boiling point/boiling range.
- Initial boiling point and boiling range.
- Flash point.
- Flammable range.
- Auto-ignition temperature.

The SDS may not contain any item on the above list because information may not be relevant or not available. When this occurs, a notation to that effect must be made for each chemical property, relevant property or item on the list. Such as the odor threshold.

Section 10: Stability and Reactivity

THIS SECTION DESCRIBES THE STABILITY OF THE CHEMICAL AND THE CHEMICAL STABILITY INFORMATION.

- Stability**
 - Description of the specific test data for the chemical. This data can be for a class or family of chemicals or for data adequately represent the individual chemical (the chemical), where possible.
- Chemical stability**
 - Indication of whether the chemical is stable or unstable under normal ambient temperature and conditions where it is stored and being handled.
 - Description of any substances that may be released or the chemical stability.
 - Indication of any safety issues that may arise should the product change in physical appearance.

- Other**
 - Indication of the possibility of hazardous reactions, including a statement whether the chemical will react or polymerize, which could release toxic products or heat, or create other hazardous reactions. Also, a description of the conditions under which hazardous reactions may occur.
 - List of all conditions that should be avoided (e.g., heat, flame, sparks, shock, vibration, environmental conditions that may lead to hazardous reactions).
 - Indication of any safety issues that may arise should the product change in physical appearance.

Section 11: Toxicological Information

THIS SECTION PROVIDES TOXICOLOGICAL AND HEALTH EFFECTS INFORMATION OR INDICATES THE TOXICITY OF THE CHEMICAL.

- Information on the study routes of exposure (inhalation, ingestion, skin and eye contact).
- The SDS should indicate if the information is relevant.
- Description of the study route of exposure (inhalation, ingestion, skin and eye contact).
- The numerical measure of toxicity (e.g., acute toxicity estimates such as the LD50 (median lethal dose) or the estimated amount of a substance expected to kill 50% of test animals in a single dose).

- Indication of whether the chemical is listed in the National Toxicology Program (NTP) report on Carcinogen Studies (NTP Carcinogen Studies).

Section 12: Ecological Information

THIS SECTION PROVIDES INFORMATION TO EVALUATE THE ENVIRONMENTAL IMPACT OF THE CHEMICAL IF IT WERE RELEASED TO THE ENVIRONMENT.

- Data from toxicity tests performed on aquatic and/or terrestrial organisms, where available (e.g., acute toxicity, chronic toxicity, reproductive toxicity, and other appropriate data).
- Whether there is a potential for the chemical to persist and degrade in the environment (e.g., biodegradability, photodegradability, and other appropriate data).
- Results of tests of the chemical's potential, making reference to the potential water solubility (e.g., acute toxicity, chronic toxicity, reproductive toxicity, and other appropriate data).
- The potential for a substance to enter into the ground-water (indicate results from absorption studies or leaching studies).
- Other adverse effects (e.g., environmental fate, acute toxicity, chronic toxicity, reproductive toxicity, and other appropriate data).



Section 13: Disposal Considerations

THIS SECTION PROVIDES GUIDANCE ON PROPER DISPOSAL PRACTICES, INCLUDING ON RECOMMENDED DISPOSAL METHODS, DISPOSAL OF CONTAINERS, AND DISPOSAL OF WASTE.

- Description of appropriate disposal methods to use.
- Recommendations of appropriate disposal methods to employ.
